The Morgan County Courthouse is closed to the public due to the COVID-19 pandemic. The PTIP Staff is in the office, Monday through Friday, 8:30AM to 4:30PM (closed 12:00-1:00PM for lunch). Continue to call color code! Drug screening is still in progress. If your color is called and you routinely report to the Courthouse for screenings, you MUST contact the PTIP Office for further instructions.

PTIP Monthly Payments (Administration Fee or Monitoring Fee) can be made electronically through nCourt at [www.morgancountydapay.com](http://www.morgancountydapay.com) or by calling 1-877-748-6252. You must provide your case number. You can mail a Money Order or Cashier's Check to PTIP, P.O. Box 1727, Decatur, AL 35602. Make payable to "PTIP." Please retain your receipt. No personal checks. Do not mail cash. Print your name and case number, clearly, on the Money Order or Cashier's Check.

Restitution/Court Costs Monthly Payments (4<sup>th</sup> Floor, Circuit Clerk's Office): You must mail a Money Order or Cashier's Check to ATTN: Circuit Clerk's Office, Morgan County Courthouse, 4<sup>th</sup> Floor, P.O. Box 668, Decatur, AL 35602. Make payable to the "Circuit Clerk's Office." Please retain your receipt. No personal checks. Do not mail cash. Print your name and case number, clearly, on the Money Order or Cashier's Check.

Thank you for your cooperation. The PTIP Staff will continue to work with each participant during this time.
